The Facility Specific Medical Gas Systems Maintenance Personnel "Training Certificate Program's" consist of Specific Training on the Inspection, Preventative Maintenance, Troubleshooting, Repair and Testing of Specific Equipment located in a particular Healthcare Facility in accordance with Original Equipment Manufacture Requirements as well as Applicable ASSE Standard 6040 & NFPA 99 Requirements.

The Programs are designed to teach only that which is required of the Maintenance Personnel in that facility as determined by the Facility Managers. The Training is "Hands On" and is conducted at the Healthcare Facility on the Facilities Equipment.

The Course will be taught by a certified NITC/ ASSE 6050 Medical Gas Systems Instructor.

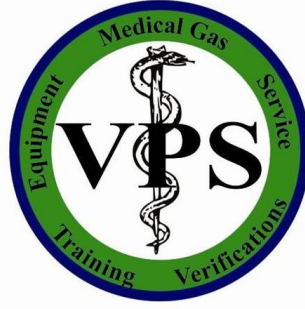
The courses can be customized to meet the specific needs of each facility; several current Training Certificate Programs are listed below.
